RE: Completion of Roadway Improvements at Ft Loudoun Middle School Entrance from Highway 11

Dear Mr. Johnson:

Over the past several months, the City of Loudon Planning Commission has discussed the delay and inquired about the status of the Ft. Loudoun Middle School intersection improvements at Highway 11. In January at the request of the Planning Commission, Mr. Jason Vance, Director of Schools, graciously attended a Commission meeting to explain that the primary cause for project delay was the need to acquire additional right of way.

As you may know, the improvements planned for this intersection include:

- 1. Addition of a center left turn lane on Hwy. 11
- 2. Addition of acceleration and deceleration lanes north and south of the school entry drive, and
- 3. Pavement markings and warning signals for the school zone.

While the opening and operation of the new school has gone well and without incident, the Planning Commission believes that completing these roadway improvements is important to the long-term safety of our citizens and school children. We appreciate your support and efforts in completing these improvements. Please advise us if there are any other unexpected delays in the project or changes in project plans. Thank you.
